

TO CITIZENS AND POLITICAL LEADERSHIP of the Russian Federation and Kyrgyz Republic

NO ONE, BUT WE!

70 years ago, the creators of U.N.O. were actuated by the “determination to save succeeding generations from the scourges of war” and to reaffirm faith in the fundamental rights and freedoms of human.

However, for seven decades, the United Nations have not managed to exclude a war not only from social relations between people and nations, but also from relations between states, which recognized the above mentioned goals with signing and ratifying the UN Charter.

As the events show, the danger of mutual nuclear destruction in relations between permanent members of the Security Council has turned to be the means to prevent the new world war just due to the continuous local wars, which serve to stimulate the vitality of rapacious economy.

The practice of local wars undermines or demolishes the productive forces of nations. The local conflicts overgrow into the chain reaction. It makes the world community bear growing losses to dampen down the controversies. Besides, the expenditures to restore the infrastructure both after “war calamities” and natural cataclysms are exponentially growing in different parts of the world. All those disasters narrow down the capacity of nations to provide and guarantee the rights and freedoms of their citizens.

For that reason, the UN actual success in reaffirming the global faith into the rights and freedoms of human personality has turned into the natural disaster for the West-European civilization.

The belief into the rights and freedoms has overgrown into the indisputable convictions of every migrant that the system of the rights and freedoms must be economically provided with the growth of productive forces of civilization, which recognizes these norms as its social value.

However, the consuming convictions are not at all capable to turn the migrant mass into the source of global economy growth. At best, it is its ballast, while at worst, it is the source of the regressive radical activity.

The roots of the tragedy are veiled with an alleged “choicelessness” of the model of the economic relations, which has become the basis of the global system both of the material and the intellectual production and exchange.

Migrants and refugees are trying to escape from the consequences of “choiceless” economic policy that the transnational corporations of the advanced nations have to implement in the poorest countries.

The movement of masses yearning for the advantages of west-european civilization exposes the actions of the historic malfunction both in the global system of economic relations and in the system of international security.

Being remained as an attribute of economy, a war deprives the global economy of the possibility to gain the source of growth adequate to the nature and the scale of the global world order, while the scientific and technological equipment of nations is turning not only into the tool of technogenic conflict with nature and involuntary self-damage of people and nations, but also into the means of civilization’s self-destruction.

The inclination of the US and the allies to charge the vices of globalization to authoritarian regimes and to give systematically their leaders to the crowd for tearing them into pieces is an evidence of intellectual impotence of the advanced nations, which has not have clear answer to the question, **HOW AND WHICH WAY TO PROVIDE THE PEACEFUL AND PROGRESSIVE DEVELOPMENT OF THE GLOBAL ECONOMY.**

The jubilee session of the UN General Assembly is starting its work in the situation of another conflict of interests between the US and the Russian Federation.

The immutable basis of political relations between the Kremlin and the White House is reproducing the Ukrainian version to escalate the international tension and is additionally involving Russia in the Syrian military conflict.

In the face of the systemic crisis of the global governance, the pursuit to crash the authoritative regimes of Bashar al-Assad and Vladimir Putin deprives the world community of its capability to comprehend that the Islamic State is not the same as the “Right sector” in Ukraine.

The emergence of the Islamic State symbolizes the point of no returning in the historical decay of Homo sapiens civilization.

The political divergence of the Kremlin and the White House is turning not only the designated regimes, but also Earthlings’ civilization into the victim of the historical blindness of advanced nations.

The conflict of interests between the permanent members of the Security Council – the US and Russia, is the consequence of the intellectual VACUUM, the emergence of which Alexander King and Bertrand Schneider attributed to the “collapse of communism”. The essence of that special state of “emptiness” consists in the following.

The intellectual forces of the professional science of the entire community of nations are being inside and in the power of the existing system of economic relations. They are deprived the possibility to glance at the problem another way and from the economically independent position. Therefore, the official science of all nations, in principle, cannot find the way to weed the war out of the life of human population.

The way to eliminate the malfunction was discovered in 1984 by the forces of the amateur research group “Argus” working from 1980 to 1983 at Frunze Polytechnic Institute in Kyrgyz SSR.

The discovery of “Argus” group was implemented under the unique historical conditions of the conceptual contention of the two socio-political systems, which had a claim on the global governance.

The liquidation of “Argus” group was fulfilled by the efforts of KGB of the USSR that relied on the moral and intellectual crime of the Soviet academic science. This way was created the deadlock condition of “choicelessness” in the fatal development of civilization.

The history of this crime of the Soviet system of governance in every detail is known only to citizens of the two states – assignees of the USSR and the members of United Nations Organization – the Kyrgyz Republic and the Russian Federation.

“Noosphere” Open Scientific Association has preserved and multiplied the results of the unique scientific research. Therefore, only those two nations have in their disposal the key to the solution of the general tasks of the peaceful outcome of the community of nations of the global socio-economic crisis.

The fundamental possibility to banish war out of the life of nations and to raise human civilization onto the qualitatively new stage of scientific and technological development entirely depends on the contents of the appearance of Russia and Kirgizia at the UN jubilee session.

The further hushing up this possibility is inadmissible.

For the political administration of Russia and Kirgizia, the fact of concealing this knowledge equals to war crime against humanity.

By force of the historical circumstances, the possibility of humanity’s outcome into the sphere of reason or irrevocable decay of civilization depends only on us – citizens and the political leadership of Russia and Kirgizia.

In order that the jubilee session of the UN General Assembly could become the turning event in securing peaceful coming for nations out of the systemic crisis of civilization, we have the honour to propose the following program of global actions to Presidents Vladimir Putin and Almazbek Atambayev.

1. From the United Nations rostrum, to make a suggestion to prepare, for the next session of the General Assembly, the package of fundamental decisions to provide the peaceful and progressive development of the system of national and global governance.
2. To initiate the new format of the international interaction to create the Special Scientific Laboratory for the Common Cause of Nations (SSL CCN).
3. To instruct the CCN Laboratory to scrutinize, in two stages, the issues of the physical, methodological and organizing-technique practicability for the transition of nations from the exploiting technologies to the technologies of guiding natural processes.
4. In line with the proposal of NOOSPHERE Open Scientific Association (<http://sdoronin.ru/images/stories/pdf/physicsbasis2.pdf> See the Document № RF-1-2015 of April 2015 – “On the Physical Basis of Human Development” Section 11), to ensure the first stage of the CCN Laboratory’s work in the territory of the Russian Federation and the second one – in the territory of the Kyrgyz Republic.
5. The results of the work of the CCN Special Scientific Laboratory and the Program of global actions should be placed for consideration and the approval of the UN General Assembly of 2016.
